- (2) All owners and operators of participating vehicles both World War II and modern era that may be used to transport and move personnel on and about the location of this event, and:
- (3) The landowner, that of a private owner or of the U.S. Government and/or any other official organizations including their officers, officials, employees and agents that may allow the use of their facilities.

For any and all damages of any kind or nature to my person and property arising out of or resulting from my direct or indirect participation in this event, I will not hold Army Group 1944 and any other organizations participating in or with this event liable for lost equipment or personal property. I understand I bring these items at my own risk to be used.

RELEASE: I desire to participate at my own risk in this event. I will take all safety precautions necessary thereto, assuming sole and full personal responsibility for ensuring that all reasonable foreseeable safety requirements are met to my personal satisfaction prior to my active participation in such an activity. I state that I am in good health, physically fit to engage in this activity and have no medical condition which could foreseeable jeopardize my safety during such participation or be aggravated by such participation. I personally hereby forever release, acquit, discharge and hold harmless any and all groups, organizations, and people that are involved with this event from any and all causes of action, including personal injury, death and property damage, costs, charges, claims demands and liabilities of any kind, name or nature in any manner arising out of or in connection with my participation in this event. I understand and agree that I may be liable for any damage or loss to other participants, organizations or landowners that are caused by my negligence, willful misconduct, or fraud while participating in this event.
